Baking Soda Bottle Rocket Contest

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

ELIGIBILITY: The ARM & HAMMER Baking Soda Bottle Rocket Contest (the “**Contest**”) is open only to individual, legal residents of the 50 United States and the District of Columbia (“D.C.”), who are 18 years of age or older as of the date of entry (19 or older in AL and NE, 21 or older in MS) (“**Entrant**”). Employees, officers and representatives of Church & Dwight Co., Inc. (“**Sponsor**”), Cohen-Friedman Associates, LLC (“**Administrator**”) (collectively, the “**Contest Entities**”), and each of their respective parent companies, affiliates, subsidiaries, advertising, fulfillment and marketing agencies, and members of the immediate families (spouse, parent, grandparent, child, grandchild, sibling and their respective spouses, regardless of where they reside) and households (whether related or not) of any of the above are not eligible to participate in the Contest. Void outside of the 50 United States/D.C. and where prohibited or restricted by law, rule or regulation. The Contest is governed by these Official Rules and is subject to all applicable federal, state and local laws, rules and regulations. Unless otherwise indicated, all language contained herein applies to the Contest. By participating, you agree to be bound by the Official Rules and the decisions of the Sponsor and Administrator, which are final and binding in all respects.

CONTEST TIMING: The Contest begins at 12:00:01 a.m. Eastern Time (“**ET**”) on Friday, September 15, 2023 and ends at 11:59:59 p.m. ET on Sunday, November 5, 2023 (the “**Contest Period**”). The Sponsor’s computer is the official timekeeping device for this Contest. Eastern Time shall control for all purposes of this Contest. All eligible entries will be judged by a pre-defined judging criteria (as later defined in these Official Rules), to determine the winner (“**Winners**”).

HOW TO ENTER THIS CONTEST:

To enter, visit www.bakingsodarocket.com during the Contest Period.

- Follow the directions to complete all required information on the entry form, including uploading an eligible submission (“**Eligible Entry**”).
- Agree to the Official Rules and submit completed Eligible Entry to receive one (1) entry into the Contest. All Contest entries must be received by 11:59:59 p.m. ET on Sunday, November 5, 2023.

An eligible submission will consist of a video of a bottle rocket as designed and launched by you and your child, along with a message to space (an “Eligible Submission”). The message to space can be read in the video and/or submitted via the entry field form.

The entrant must have its child participating in the Eligible Submission and the child must be at least seven (7) years of age and wearing safety goggles for the Eligible Submission to be considered valid and eligible for entry into the Contest.

Your Eligible Submission must include the use of ARM & HAMMER™ Baking Soda.



NOTE: Video upload requirements/parameters: Videos may not exceed seven (7) minutes in length, file size must be 120MB or less, and in one of the following formats: .mov, .mp4, and .m4v . Videos must also be in compliance with the Eligible Entry Requirements set forth below.

Once an Eligible Entry has been approved by Sponsor, the Eligible Submission may be added to the content gallery on the Contest site. By submitting an entry, you agree that your submission is gratuitous and made without restriction, and will not impose any obligation upon Administrator or Sponsor. Administrator and Sponsor are free to disclose the ideas contained in the Eligible Submission on a non-confidential basis to anyone and are free to otherwise use the Eligible Submission, in whole or in part, without any additional compensation to you. You acknowledge that, by acceptance of your Eligible Submission, Sponsor does not waive any rights to use similar or related ideas previously known to Sponsor, or developed by its employees, or obtained from sources other than you.

PARTICIPATION IN THIS CONTEST IS AT YOUR OWN RISK. YOU SHOULD NOT ATTEMPT ANY ACTIVITY THAT IS BEYOND YOUR SKILL LEVEL. PARTICIPANTS ACKNOWLEDGE THE INHERENT DANGERS AND RISKS ASSOCIATED WITH BUILDING AND LAUNCHING BOTTLE ROCKETS (“**ACTIVITIES**”), AND THAT THERE ARE NATURAL FACTORS AND OCCURRENCES WHICH MAY IMPACT ON OR AFFECT THE SAFETY OF SUCH ACTIVITIES AND PARTICIPANTS (ON THEIR OWN BEHALF AS WELL AS ON BEHALF OF THEIR PARTICIPATING CHILD) KNOWINGLY AND VOLUNTARILY ASSUME THESE RISKS AND DANGERS.

Grant of License:

By submitting an Eligible Entry, each Entrant grants Sponsor and/or the participating partners of the Contest, if any, a perpetual, worldwide, irrevocable, non-exclusive, royalty-free license to transform, edit, modify, reproduce, distribute, transmit, publish, broadcast, perform, display, or otherwise use the Eligible Entry, in whole or in part, including but not limited to, the right and license to use and/or display the image, likeness, picture, portrait and/or voice of Entrant and/or Entrant’s child as may be depicted in the Eligible Entry, in whole or in part, with or without modifications, in any form or medium whether now existing or later developed, for any and all purposes without limitation and without further compensation, notice or approval from such Entrant. Contest Entities do not guarantee the posting of any Eligible Submission on the gallery page and are not liable for the use of any entry by any third party. Contest Entities have the right, but no obligation, to use an Eligible Entry or any portion thereof for any purpose, as they may determine in their sole discretion. Entrant may be required to execute any and all documents deemed necessary or otherwise required by Contest Entities, if any, as determined by Contest Entities in their sole discretion, to effectuate such grant.

Eligible Entry Requirements: Once an Eligible Entry has been submitted, Entrant cannot access/revise its entry in any way. An Eligible Submission must be Entrant’s own original work, created solely by Entrant and not created professionally; must be in English; must not have been previously published, released or distributed in any form; and must not have won any award. Entries must not advertise or promote third parties’ goods or services, nor contain any material which violates or infringes any copyright, trademark, trade name, trade secret, right of publicity or privacy or other personal and/or proprietary right of any person or entity. Entries must not use third party artistic works, music, sound effects, poetry, copyrights, trademarks, trade names, logos, similar brand identifying marks, trade secrets or other proprietary rights. Entrants may however use the Church & Dwight Co., Inc. trademark/products in the



Eligible Submission. Entrant's Representations and Warranties/Indemnification: By submitting your Eligible Entry, you represent and warrant that with respect to all components of the Eligible Entry: (i) the Eligible Entry is original, (ii) you own the Eligible Entry or otherwise have the right to submit it to the Contest and to grant the rights to the Eligible Entry that are granted by you herein and that such Eligible Entry does not violate or infringe upon the intellectual property rights or other rights of any third party, including but not limited to, rights of privacy and publicity; (iii) the Eligible Entry has not been previously published in any medium; (iv) the Eligible Entry does not and will not violate any applicable laws and is not and will not be considered defamatory or libelous; and (v) the child depicted in the Eligible Submission is the child of Entrant and is seven (7) years of age or older. Each Entrant hereby agrees to indemnify and hold the Sponsor and its subsidiaries, affiliates, divisions, partners, representatives, agents, successors, assigns, employees, officers, and directors harmless from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the representations, warranties or agreements of Entrant hereunder.

Limit of one (1) unique entry per person. **Limit** of one prize per person or household. Entries that are generated by a script, macro, or other automated means and/or otherwise not in compliance with these Official Rules will be disqualified. Automated methods of entry, including entry via third party websites or services, are prohibited. All entries become the property of Sponsor and will not be returned or acknowledged.

JUDGING CRITERIA/WINNER SELECTION: All Eligible Entries will be judged by the Sponsor or Sponsor designated representatives, as determined by the Sponsor in its absolute sole discretion. Each Eligible Entry will be judged and assigned up to 100 total points based on the following weighted criteria.

- 0-60 points Bottle Rocket Technical Design and Rocket Flight
- 0-40 points Overall Creativity

At the end of the Sponsor's Judging, one (1) Eligible Entrant with the highest total point score will become the Grand Prize Winner (pending verification). In the event of a tie for the Grand Prize Winner, a third party judge selected by the Sponsor will judge the tied entries based on the above criteria to determine the winning entry from the tied entries. The decisions of the Judge are final and legally binding and cannot be appealed.

Winners will be notified on or about November 15, 2023.

PRIZE: No more than the stated number of prizes will be awarded in this Contest. Selected Grand Prize Winner must agree to having their winning bottle rocket video and message featured in all digital media, including but not limited to display ads, paid/organic social media and Arm & Hammer's landing page, bakingsodarocket.com.

One (1) Grand Prize: Two (2) spots in Family Space Camp for one adult and child or one (1) spot in Space Camp for a child in the summer of 2024. Winner will have a choice between either (i) a Family Space Camp for up to two (2) people (one adult age of 18 or older) and one child between the ages of 7-18) for two (2) nights or (ii) a Space Camp for one child between the ages of 9-14 for up to six (6) nights. Approximate retail value ("ARV") of entire Grand Prize is of up to \$1,700. Travel to/from Space Camp or any other costs/expenses that may be associated with attending Space Camp are not included as part of the prize.

Sponsor will not replace any lost, mutilated, or stolen prize.

Prize is not transferrable or assignable. Sponsor reserves the right to substitute any Prize (or portion thereof) for a prize of equal or greater value in the event an offered Prize (or portion thereof) becomes unavailable for any reason. CONTEST PRIZE WINNER NOTIFICATION/VERIFICATION: Potential Contest prize Winner will be notified by email based on the address used to register for the Contest. Potential prize winner must respond to such email with the requested information within four (4) calendar days from the time at which winner notification is sent by Sponsor or Administrator, or the Prize may be forfeited and awarded to an alternate winner, at Sponsor's sole discretion. Prize winner will be required to



complete, sign and return an affidavit of eligibility, liability release and (where lawful) a publicity release and, for prize valued at \$600 or more, an IRS Form W9. Failure to sign and return these documents within the stated deadline may result in forfeiture of the Prize and selection of an alternate potential winner. An alternate winner will be defined as the entry with the next highest judge's total score from among all remaining Eligible Entries received. Prize will be awarded if properly claimed. Noncompliance by date specified for the return of the documents or return of these documents or any Prize or prize notification as undeliverable, will result in disqualification. Sponsor and the other Contest Entities are not responsible for any change of email address, inactive email accounts, a potential Winner's failure to monitor its email account or emails not received due to spam filters or other technical issues outside their control.
